

# Player Representation Agreement BIP/DVA Volleyball Management

I \_\_\_\_\_ am hereby selecting, Bring It Promotions, LLC (BIP) and Diamar Volleyball Agency (DVA) to promote and represent me as a volleyball player and understand the following:

I currently have no existing, nor can I make new written or verbal contracts, with any other player agent or agency, scout, or representative for the season 2008-2009 ending June 1<sup>st</sup> 2009. If no letter is received by March 1<sup>st</sup> 2009 from me requesting a release from BIP/DVA Volleyball Management then this agreement will extend until June 1<sup>st</sup> 2010 under the same conditions.

I agree that to play with any professional volleyball team, the contract must be procured and negotiated by BIP/ /DVA Volleyball Management and their partners. I appoint BIP/DVA Volleyball Management and their partners, representation rights to deal with everything concerning finding me a volleyball team anywhere in the world. This includes but is not limited to the contacting of teams, negotiations with teams, and the drawing up of any contract with any team.

The appointment of BIP/DVA and their partners, as my representative, is effective for all of the time that I will play on any team in any country.

## **TERM OF AGREEMENT:**

BIP/DVA and their partners will give their best effort to find a team suitable to my qualifications.

BIP/DVA and their partners will conduct the negotiations, with any team in any country, exclusively on my behalf, but with complete coordination with me.

In the matter of financial compensation (salary and bonuses), I will have sole discretion and will be the only one to sign any contract with any team.

I am obliged not to contact any team in any country, in any way, but through BIP/DVA and their partners. Any communication to me from any team, manager, coach, or federation will be immediately referred to BIP/DVA for the purpose of negotiations.

For these services, as stipulated in this agreement, the club will pay the BIP/DVA a maximum fee of 10% of any base contract signed between the player and team, during the term of the agreement.

## **THE FEE**

The fee will be paid by the club according to the total amount of my base salary. No bonus compensation will be included.

The payment of fees to BIP/DVA will be by the club after my contract is finalized and signed and before the release of my FIVB transfer certificate.

I am obligated to support BIP/DVA in receiving, from the club, this representative fee. This is a part of my contract.

I understand that a paid FIVB Transfer is required for all foreign contracts and ask that my national federation does not release my FIVB Papers without written consent from BIP/DVA.

I understand that if I agree to stay on a team where BIP/DVA Volleyball Management has made the initial placement, regardless of the time of the placement, the team will pay the up to 10% agency fee of each subsequent or revised contract.

I hereby understand if I am placed on any team during the period of this contract and my current team requires players for the duration of the season or the following year that any suggestions of players will be brought through the representation of BIP/DVA Volleyball Management and not the player directly.

I give BIP/DVA Volleyball Management the right to use my name and image in promotional materials for BIP/DVA Volleyball Management related tournaments, tours, foreign club teams, and all BIP/DVA Volleyball Management sponsored events.

I can rescind this player representation agreement subject to the payment of 3.000 Euros. Upon receipt of this amount, BIP/DVA Volleyball Management will provided me with a release letter stipulating that the player representation agreement has been rescinded.

I understand that any contract with any club can be broken from the moment that I do not properly offer my services as a professional volleyball player. I understand that I need arrive in shape and prepared to maintain a respectful athletic way of living. I need to observe the internal regulations of the club, national league, national federation, FIVB, and the regulations of law in any country in which I am playing. I must also abide the decisions of and club, league, or official authorities as regards technical, athletic, and/or disciplinary content, which constitutes an inseparable part of the present agreement.

If the case arises where a club has not paid me on time, BIP/DVA and their partners will take responsibility to force the club to adhere to their financial obligations. I understand that I need to notify BIP/DVA within one week of any late or partial payment.
